



Cargo Trailers

6 x 12 (single axle) ---- 1st day \$50 /// \$35 each additional day

7 x 16 (tandem axle) ---- 1st day \$75 /// \$50 each additional day

Towing Vehicle must be of proper size, have the proper hitch and light plug connection. The 7x16 trailer requires your tow vehicle to have a working brake controller. Due to insurance reasons we cannot rent trailers to customers who are using a rented vehicle. We reserve the right to refuse any rental, if not comfortable with the condition of your tow vehicle.

Rental Period - Rental period must be for at least 24 hours. Full price on Day 1 –every day there after is discounted as above. Pick up of the trailer is By Appointment only between 9am -4pm Monday through Friday and 9am -12pm Saturdays. Rentals returned on weekends or after business hours will not be checked in and inspected for damage until the next business day.

Reservation Deposit is required on all rentals and is equal to 1 day rental. The deposit must be accompanied with the completed paperwork to secure your reservation. The reservation deposit is non-refundable and goes toward your rental contract.

Damage Security Deposit is required on all units at time of departure. The damage security deposit for the 6x12 trailer is \$100 and for the 7X16 trailer is \$150. The security deposit will be refunded if the rental unit returns in the same condition it was as when it left.... Cleaned, not damaged or abused, etc. If paying by personal check your refund could take up to 10 business days. Rental refunds are issued Monday -Friday.

Insurance for the rental unit only is included with your rental fees and is subject to a \$1000 deductible if an accident should occur. Included is the state minimum liability coverage for the rental unit only and does not extend to you, your vehicle or any personal contents.

****Beckley's RV Rentals will not be responsible for any damages to personal contents loaded inside the trailer nor for any items secured or unsecured during the time of your rental contract. If your personal contents damage the rental trailer in any way while under contract, you understand you will be responsible to pay for these repairs. By signing these terms and conditions, I understand this liability and responsibility. If damage should occur, an estimate will be done by us and a copy will be provided to you once all the damages are accessed. If the damages are less than \$1000, you would be responsible for the full amount of the estimate. If over \$1000, you are responsible for the \$1000 deductible and will forfeit any refund of the damage security deposit.

Extras -We rent wheel chocks, D rings for the floor, and a set of (4) ratchet tie down straps for an additional charge. If you are interested, please specify this request on the reservation form or ahead of time as quantities are limited.

D rings & Straps – D rings and set of 4 straps – each strap is adjustable up to 16 foot and each strap is 1.5” wide. The straps have a quick release feature and double hooks on each strap. The rental rate for a set is \$15.

Wheel chocks – The 6x12 trailer has the ability for (1) chock and the rental rate is flat fee of \$25 per chock. You can rent up to (2) chocks for \$50 to fit into the 7x16 trailer.

If the straps or bike chocks return damaged or missing, you will be charged for the replacement of these parts.

Paperwork including proper identification, current and valid insurance policy or ID card for the tow vehicle is required before departure of the cargo trailer. We do not “hold” or accept verbal reservations. A rental reservation form with employment information must be completed to start your reservation. Both the reservation form and this page of the terms and conditions along with your paid reservation deposit must be submitted to make your reservation complete. All drivers must be 25 or over to drive or rent any of our rental units.

All fees are payable by credit card, cash, or personal check. Damage security deposit, MD sales tax, and remainder of the rental contract are required to be paid in full day of departure or prior, no exceptions. If paying by personal check your refund could take up to 10 business days to process.

We reserve the right to refuse any applicant. Terms and conditions are subject to change without notice. I have read and understand the rental terms and conditions.
