### PAYMENT / DEPOSIT

Rental units can be held risk-free for up to **7 days** by submitting **10%** of the rental amount (does not apply within 5 weeks of departure). Reservations are finalized by submitting **full payment** of the estimated rental charges. Adventure Rentals & Leasing, LLC accepts Cash, Certified Check, Money Order, Personal Check, or Credit Card. Payment must be in the **primary renter's name**, and (if applicable) the Credit Card used must be present along with the primary renter on the day of departure. In addition to all rental charges there is a **refundable Deposit** required 14 days prior to departure. The Deposit amount will not be less than \$500 more than the highest deductible on the active insurance for the Rental, and never less than \$1,000 (some Luxury Units require a higher Deposit).

### CANCELLATION / RESERVATION CHANGES

From the date of the reservation to **29 days** prior to departure, Adventure Rentals & Leasing, LLC will refund your rental payment **less the greater of: 10%** of the total rental amount, **or \$150.00**. From 28-22 days (**4 weeks**) prior to departure the refund amount will be 75% of your rental payment, from 21-15 days (**3 weeks**) the refund will be 50%, from 14-8 days (**2 weeks**) the refund will be 25%. If you cancel less than 8 days (**1 week**) from your scheduled departure, refuse to accept delivery, or are unable to comply with our requirements (see above and below) at departure, **NO REFUND** will be given. Changes to the reservation may incur charges. See our Terms & Conditions for more information and exceptions, or ask your rental associate for details.

### IMPORTANT INFORMATION

**A)** The person named on this Rental Application must be at least 25 years of age and is the **only person** authorized to sign our rental agreement and take the unit off our lot; **B)** Adventure Rentals & Leasing, LLC reserves the right to substitute a vehicle of equal or greater value, or refund your rental payment due to unavailability of the unit; **C)** No refund or discount will be issued if the unit is returned prior to the scheduled day / time; **D)** The unit is not permitted into Mexico, Alaska or where communications by phone or cellular phone are not available; **E)** Smoking is absolutely prohibited at all times; **F)** Pets or Towing of any type is prohibited unless approved prior to pick up (additional fees may apply); **G)** Any departure before close on the departure day is considered on time; **H)** Any additional drivers must be listed on the rental contract, present (with valid license) at pick up / departure, and comply with the Terms and Conditions (including driving record, age, and insurance requirements).
